I was particularly moved by that decorum in Jason Hulce, Gary Saddler and Tab Mitchell and enjoyed the agree to disagree with focus on problem solving themes.

After much deliberation on recent issues I felt that my continued role was becoming unacceptable in the behavior vented and full disrespect for the processes of a valid meeting. My volunteer efforts are no longer effective given the anger seen in detractors. I came to recognize that my penchant for not being bullied outweighs what I can offer as trying to be an effective contributor to my neighborhood. Certainly no one in leadership over the past year has had anything but the best intent for all neighbors but

nonetheless the process introduced many great advances and some unintended problems. Even though I have 1 year remaining in my tenure on the Board, I had to consider what was best for KAP.
